# **Court issues injunction on so called** "executive council" led by Prof. A. B. M. Faroque

After a series of hearing over more than three months at the 1st Assistant Judge Court of Dhaka followed by a hearing of the civil revision case filed by the Central Executive Council (CEC) of **Bangladesh Pharmaceutical Society** (BPS), the Hon'ble District Judge of Dhaka has issued an interim injunction order upon the so called "executive council" formed by Prof. A. B. M. Farook, prohibiting them from representing BPS at any forum and also prohibiting them from introducing themselves as members of the executive council of BPS. The aforesaid interim injunction order of the Hon'ble Court was issued on 25th November 2009 at Dhaka.

The court order came after the present CEC had submitted various important documents to the court in favour of the legitimacy of the Central Executive Council led by Mr. Md. Nasser Shahrear Zahedee as President. The CEC of the **Bangladesh Pharmaceutical Society** has welcomed the decision of the Court. The CEC observed that the decision would further facilitate the professional activities of the Pharmacists towards development of the pharmaceutical sector.

Although, the PSEP was renamed as BPS, no initiative was taken to regularize the documents for registration as a professional body under Societies Act. The information on the registration status of PSEP and BPS was collated from the archive of Ministry Prof. Dr. Abdul Jabbar of Commerce in early 2006 when the CEC took an initiative to update the registration. After having put efforts for a couple of years, it became evident that the registra-1968 tion of PSEP became defunct and it was almost impossible to restore it after about 36 years of irregularities, as it would require a number of documents including the audit reports, AGM records and other similar documents of last 36 years. The last CEC then took the initiative to get Dr. A. M. M. Khan BPS registered under the Societies Act and this very task was accomplished on 18<sup>th</sup> January 2009. Now it is a pleasure for the Pharmacists that the Bangladesh 1972 Pharmaceutical Society is duly registered under the Societies Act 1860 (Act XXI of 1860) and the registration number of Bangladesh Pharmaceutical Society is "S 8683". **Prof. Dr. A.
